## NOTICE OF 57<sup>TH</sup> ANNUAL GENERAL MEETING AND E-VOTING INFORMATION

Notice is hereby given that an 57<sup>th</sup> Annual General Meeting (AGM) of the Members of the Company will be held on Saturday, 29<sup>th</sup> September, 2018 at 10:30 a.m. at Sir Jacob Sasoon High School, 340 J.J. Road, Byculla, Mumbai-400008 to transact the business as set out in Notice of 57<sup>th</sup> AGM. The Register of members and share transfer book will remain close from Saturday, 22<sup>nd</sup> September, 2018 to Saturday, 29<sup>th</sup> September, 2018 (both days inclusive) for the purpose of AGM.

In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (LODR) Regulations, 2015 the Company is providing to its members, facility to cast their right to vote using an electronic voting system from a place other than venue of the meeting ("remote-e-voting) for all the business to be transacted at the 57<sup>th</sup> Annual General Meeting.

The e-voting shall commence on Wednesday, the 26<sup>th</sup> September, 2018 at 9:00 am and end on Friday, 28<sup>th</sup> September, 2018 at 5:00 pm. The remote e-voting facility shall not be allowed after the aforementioned end date and time. The cut-off date to determine eligibility to cast votes by electronic means or in the 57<sup>th</sup> AGM of the Company is 22<sup>nd</sup> September, 2018.

The members who have not cast their votes by remote e-voting can exercise their voting rights at the 57<sup>th</sup> AGM. The Company will make arrangements for polling papers in this regard at the venue of 57<sup>th</sup> AGM. A member may participate in the 57<sup>th</sup> AGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again at the 57<sup>th</sup> AGM.
